Tonnage - Frequently Asked Questions

Which shipments can I report?

Shipments booked by your company where at least one PAIMA Member, other than your company, handled the Origin or Destination services.

What if our company booked the shipment, but did not handle the Origin or Destination?

If both the Origin and Destination services were handled by two different PAIMA Members, you will need to make one entry to receive credit for the Origin portion and a second entry to receive credit for the Destination portion.

What if I booked a shipment and there is no PAIMA agent in the Destination country? Can I report this shipment?

No, this shipment cannot be reported. If you have an agent that you would be willing to Sponsor, please ask them to become a Member.

What shipment dates are allowed?

Booked shipments with a Bill of Lading date from August 1st, 2015 thru July 31st, 2016.

What is the deadline?

The website portal will stay open for an additional 30 days to allow Members to enter their Tonnage from the previous month. The Portal will be closed on August 31st, 2016 and the new reporting period will begin.

Who will receive an award?

The Members with the highest and second-highest reported tonnage in their region will receive a plaque. All Members that reported at least one shipment will be recognized and receive a certificate for participation.

What if I receive a request from the PAIMA office to verify my Tonnage entries?

All Members that participate in the Tonnage Program will receive a request for verification on several of their shipments. Please send back a copy of the Bill of Lading for that shipment showing the date, shipper's name and weight of the shipment. We appreciate your cooperation.
